Sri N.Adinarayana Reddy, S/o Peda Venkata Reddy & Others Residents of Kakarla Village & Post, Arthaveedu Mandal Prakasam-Dist-523333 herein called the complainants, in their complaint dt:14-9-2012 filed in the Forum on dt:14-9-2012 under clause 5 (7) of APERC regulation 1/2004 read with section 42 (5) of I.E.Act 2003 have stated that

- 1. They are agl. consumers under SS-2 of Kakarlla Village in Ardhaveedu mandal of Prakasam Dist having service numbers 328, 327 and 918.
- 2. There are 22 numbers borewells under the SS-2 transformer and the voltage is low for their services due to its over loading.

3. Requested for erection of additional 25KVA transformer for the said

services.

4. Since the transformer SS-2 is amidst paddy fields and there is no clear

approach to the transformer, the transformer shifted to the road side for

easy access.

Notices were served upon the respondents duly enclosing a copy of complaint.

The respondent-1 i.e. the Assistant Engineer/Operation/Arthaveedu in his

written submission dt:01-10-2012 received in this office on dt:11-10-2012 stated

that:

1. He personnaly inspected the SS-2 100KVA dist. transformer and found

that is over loaded.

**2.** He prepared an estimate for erection of a 25KVA transformer additionally

and got sanctioned by the DE/Opn/Markapur.

3. The material indent was submitted by the ADE/OPn/Cumbum to the

SE/Opn/Ongole on 25-09-2012.

**4.** For shifting of the SS-2 Kakarla 100 KVA transformer a letter was

addressed to the complainants to pay the necessary charges towards

shifting of the said transformer and upon receipt of the amount the

transformer will be shifted.

**Findings of the Forum:** 

1. The grievance of the complainants comprises of two items out of which

the first one is about low voltage for their agl. services and the second one

about shifting of the transformer.

2. The respondents for the first item i.e. about low voltage rectification

replied that an estimate was sanctioned and material indent was also

submitted to the SE/Opn/Ongole i.e. the respondent-4 and the material

receipt are awaited.

3. In accordance with Guaranteed Standards of Performance, the problem of

low voltage shall be resolved within 120 days from the date of the

complaint and here in this case since the complaint was made on 11-09-

2012 the problem is to be resolved by 10-01-2013.

4. The respondents are liable to compensate the complainant @ Rs 50/- for

each day of delay beyond 10-01-2013.

5. The second item of the grievance is about shifting of the existing 100KVA

transformer from the middle of the paddy fields to the road side for which

the respondents reported that they have prepared an estimate towards the

said shifting and intimated the complainants to pay the charges according

to the estimate to enable them to fulfill the said shifting.

6. The contention above of the respondents in the matter of transformer

shifting is quite in order and the complainants have to bear the cost of the

shifting if they prefer for.

In view of the above, the Forum passed the following order.

**ORDER** 

The respondents are directed that

1. They shall complete the work of erecting the additional transformer as

proposed by them not later by 10-01-2013 failing which they are liable to

compensate the complainant @ Rs 50/- per each day of delay beyond 10-

01-2013.

2. They shall report compliance in the above matter by 17-01-2013.

The complainants are advised that

- 1. They shall pay the estimated amounts claimed by the respondents towards shifting of the transformer to the road side from the middle of the paddy fields if they prefer for.
- 2. They may report the matter to the Forum in case the respondents fail to comply with the item-1 of the order for respondents above.

Accordingly the case is allowed and disposed off

If aggrieved by this order, the complainant may represent to the Vidyut Ombudsman, O/o the APERC, 5<sup>th</sup> floor, Singarenibhavan, Redhills, Hyderabad-500004, within 30 days from the date of receipt of this order.
