Sri. D.Munikrishna, S/o Veera Swami resident of Vepanapalli (Village), Thenepalli (Post), Puthalapattu (Mandal), Chittoor-Dist herein called the complainants, in his complaint dt:23-5-2012 filed in the Forum on dt:23-5-2012 under clause 5 (7) of APERC regulation 1/2004 read with section 42 (5) of I.E.Act 2003 had stated that

- 1. One number 11KV line and LT lines along with a transformer are existing in the premises of school at Vepanapalli.
- 2. Requested for shifting of the above from the premises of the school.

Notices were served upon the respondents duly enclosing a copy of complaint.

The respondent-1 i.e. the Assistant Engineer/Operation/Puthalapattu in his written submissions dt:18-6-2012 received in this office on dt:23-08-2012 stated that

- 1. He inspected the location and advised the complainant to give his willing ness letter to bare the cost of the shifting of 11KV line under DC works, but the consumer was not willing to pay the charges.
- **2.** Hence the work is not taken up.

Findings of the Forum:

- 1. The grievance of the complainant is about shifting of lines and transformer from the premises of the school at free of cost.
- 2. The respondents reported that the work can be taken up only under deposit contributory (DC) scheme for which the beneficiary has to bear the cost of the estimate and the complainant did not come forward to bear the expenditure and hence the proposal is dropped.
- The contention of the respondent that the work is to be taken up under DC scheme is accepted.
- 4. The complainant if he wants the said work of shifting the lines and the transformer has to bear the cost of the shifting besides providing necessary way leave for the rerouting of the lines and for erection of the transformer.

In view of the above, the Forum passed the following order.

ORDER

The complainant is advised to render his willing ness to pay the estimated amount towards the shifting of the lines and transformer as he requested if he prefers for.
