Sri R.Sambasiva Rao S/o R.Masthan Rao D.No:40 and 9/40/A 9th Block ,Yerrabalem village, Yerrabalem Post Office , Manglagiri Mandal Guntur - Dist. herein called the complainant, In his complaint dt:12-09-2014 filed in the Forum on dt: 12-09-2014 under clause 5 (7) of APERC regulation 1/2004 read with section 42 (5) of I.E.Act 2003 has stated that:

1. He is a resident of yerrabalem village, Mangalagiri mandal , Guntur – Dist with SC.No:722.

2. In his land the HT lines is erected. He said to the lineman A.Sambasiva Rao not to erect in his land but the line man was not responded and the HT line are erected in the land.
3. In future if he wants to build a building, it will be very difficulty while passing the HT lines in his land.
4. He wants to shift the HT lines from his land .

Notices were served upon the respondents duly enclosing a copy of complaint.

The respondent-I i.e. the Additional Assistant Engineer/D 2 /Mangalagiri in written submission dt: 14-10-2014, received in this office on dt:16-10-2014 stated that:

1. He submit that he inspected the site of Sri R.Sambasiva rao, S/o R.Masthan Rao at yerrabalem village and noticed that the 11KV interlinking line was newly erected for feeding of supply from newly constructed 33/11KV yerrabalem SS by construction wing Guntur.
2. The Above interlinking line is slightly passing through the site of Sri.R.Sambasiva Rao, S/o Mastan Rao at yerrabalem village in D2-Mangalagiri Section.
3. The Estimate is prepared for erection of 1 No Middle pole with side arm for shifting of 11KV line passing through the site of Sri R.Sambasiva Rao S/O Mastan Rao at Yerrabalem(V) in D2 Mangalagiri section under T&D Improvements and submitted to the Higher Authorities .
4. As Soon as sanction of the estimate the work will be taken up and complete the work as early as possible.

Further The respondent-III i.e. the Divisional Engineer/Operation/Town 2 /Guntur in written submission dt: 27.10.2014 , received in this office on dt: 30.03.2015 stated that:

1. He submit that the complaint was filed by Sri . R.Sambasiva Rao,S/o Mastan Rao at yerrabalem in Operation Section ,D 2 –Manglagiri , regarding passing of HT lines through the consumer premises.
2. He submit that at present 1 phase of the HT line is passing near the boundary of the R&B and consumer premises .The lines are far away from the consumer shed and no danger to the consumer. After fixing the R&B

borders, if the site is belongs to the consumer ,then the line will be shifted at the time of construction of house.

Findings of the Forum:

1. Sri R.Sambasiva Rao, the complainant in his submission expressed his anguish and distress over the laying of 11KV over his site inspite of his appeal to the Respondents and he is afraid that the line may cause problem to cause problem to construct build a house there.
2. The DE/O/Town 2 /Guntur , the Respondent No 3 has categorically submitted that the lines are far away from the consumer shed and there is no danger to the consumer.The Respondent has also stated that after fixing the R&B borders, if the site is belongs to consumer, the line will be shifted .It is given to understand from the above that the Respondents without proper plan have laid the lines in the site.

ORDER

The Complainant is advised to approach the Respondent No 3 with proper evidence as to the ownship of the land in which the line underquestion was laid and the Respondents are directed to settle the issue within 15 days from the date of production of proper recorded evidence by the Complainant.

Accordingly the case is allowed and disposed off.

If aggrieved by this order, the complainant may represent to the **Vidyut Ombudsman, 1st Floor, 33/11KV Sub-Station, Hyderabad Boat Club Lane, Lumbini Park, Hyderabad-500063**, within 30 days from the date of receipt of this order.
