- 3. She wants to change Dr.No's and change to old meter to new meter.
- 4. She lodged an Complaint in the Forum for Justice.

The respondent -3 i.e. the Assistant Engineer/Operation/Kodur Town in his written submission dt:23.09.2014, received in this office on dt:26.09.2014 stated that:

- 1. The Consumer bearing SC.No:- 14656 and 14657 of Kodur Town along the above reference regarding the Change of existing door numbers recorded in our records.
- 2. The Consumer recorded door no's are 7/753-2 for Sc.no:14656 and 14657 but present door no's are 7/745-A.
- 3. The Name transfer of Sc.No:9797 is now existing in the name of D.Naveen kumar.
- 4. The Consumer advised to register an application with necessary supporting document required for name transfer like sale deed, EC Application form with test report ,passport size photo and 100/- Non judicial stamp paper etc for name transfer purpose.
