Sri.P.Pedda Nagaiah S/o Guravaiah is a resident of Thammadapalli village, Thangirallapalli – Post office ,Peddaraveedu mandal, Prakasam- Dist. herein called the complainant, in his complaint dt:18-08-2014 filed in the Forum on dt:18-08-2014 under clause 5 (7) of APERC regulation 1/2004 read with section 42 (5) of I.E. Act 2003 has stated that:

- He is the resident of Thammadapalli village ,Thangirallapalli post office,
   Peddaraveedu mandal ,Prakasam Dist.
- 2. He had borewell at S.S.4 ,Thammadapalli with 25 KVA Transformer but LT lines are not erected.
- 3. So kindly erect the LT lines to the transformer.

Notices were served upon the respondents duly enclosing a copy of complaint.

The respondent-1,II & III i.e. the Assistant Engineer/Operation/Paraveedu, Assistant Divisional Engineer/Markapur **Divisional** Engineer/Markapur in their combined written submission dt:02.06.2015, received in this office on dt:06.06.2015 stated that:

1. They submits that the estimate is sanctioned and the work is completed through the HVDS wing .The work is completed on 01.06.2015.

#### Findings of the Forum:

- 1. During the Special Vidyuth Adalath conducted at Markapur on 18.08.2014 by the Forum, Sri .P.Pedda Nagaiah has lodged a complaint before the Forum stating that, though a new Transformer of 25KVA was erected the Respondents have not laid the lines under HVDS for his service.
- 2. The Respondents after receipt of notice from the Forum, have initiated steps to sanction the estimates and completed the works as required by the complainant on 01.06.2015.

#### **ORDER**

Since the Grievance of the Complainant to erect the Line has been completed by the Respondents on 01.06.2015, the case is disposed off accordingly.

If aggrieved by this order, the complainant may represent to the Vidyut Ombudsman, Andhra Pradesh, Flat No:401,4th Floor, Ashoka Chambers, Opposite to MLA Quarters, Adarsh Nagar, Hyderabad-500063, within 30 days from the date of receipt of this order.
