Sri Pallaboina Chinna Avulaiah S/o Pedda Avulaiah is a resident of Rayavaram , Markapur ,Markapur – Post Office, Markapur Mandal , Prakasm – Dist, herein called the complainant, In his complaint dt:18-08-2014 filed in the Forum on dt: 18-08-2014 under clause 5 (7) of APERC regulation 1/2004 read with section 42 (5) of I.E.Act 2003 has stated that:

1. He is a resident of Rayavaram ,Markapur – Post Office, Markapur Mandal, Prakasam – Dist.

2. He has paid Rs 8400/- for Agricultural Service Connection through Demand Draft .
3. The estimation was sanctioned and lines are sanctioned but his neighbour Sri Kakarla Subba Rao S/o Nacharaiah has objected not to erect lines over his land.
4. So kindly rectify the problem and do Justice.

Notices were served upon the respondents duly enclosing a copy of complaint.

The respondent-I & II i.e. the Assistant Engineer/Rural Section/Markapur, Assistant Divisional Engineer / Operation /Markapur in their combined written submission dt:07.04.2015, received in this office on dt:08.04.2015 stated that:

1. The estimate is sanctioned and work is completed on 20.12.2014.

Findings of the Forum:

1. Sri P.Chinna Avulaiah of Rayavaram village, Markapur filed a complaint before Forum, during the Vidyuth Adalath conducted at Markapur on 18.08.2014 by the Forum , requesting to take necessary action in releasing agriculture service to his fields. He has expressed his apprehension that his neighbour is posing objection to lay the line over his fields.
2. The Respondents 1 and 2 in their Joint submission have stated that they have completed the works as per the grievance of the complainant on 20.12.2014 after obtaining the requisite sanctions.

ORDER

Since the grievance of the Complainant has been redressed by the Respondents by completing the works on 20.12.2014, the case is disposed off accordingly.

If aggrieved by this order, the complainant may represent to the **Vidyut Ombudsman, 1st Floor, 33/11KV Sub-Station, Hyderabad Boat Club Lane, Lumbini Park, Hyderabad-500063**, within 30 days from the date of receipt of this order.
