Act 2003 has stated that:

1. He is the resident Bhagath Singh Colony ,Markapur – Post Office ,Markapur Mandal ,Prakasam – Dist with service no:6509.

- 2. In his colony and near to his house 2 poles are damaged and ready to collapse.
- 3. So kindly rectify the problem by replacing the new poles..

 Notices were served upon the respondents duly enclosing a copy of complaint.

The respondent-1,II & III i.e. the Additional Assistant Engineer/Operation/Markapur Town,Assistant Divisional Engineer/Markapur and Divisional Engineer/Markapur in their combined written submission dt:31.03.2015, received in this office on dt:08.04.2015 stated that:

- 1. The damaged pole at the house of the Sri Nakka Venkata Ramana, Markapuram town was replaced with the new pole on 25.09-2014.
- 2. The Estimate for replacement of damage pole was sanction under S.D.R.IMP No.490/14-15, W.B.S.No.T-2014-03-02-21-01-025.

Findings of the Forum:

- 1. Sri N.Venkata Ramana of BhagathSingh Colony ,Markapur filed a petition before the Forum during the Vidyuth Adalath conducted at Markapur on 18.08.2014 and requested to replace the 2 damaged poles near his residence.
- 2. The Respondents 1,2 & 3 in their Joint submission have stated that the damaged poles were replaced with healthy one on 25.09.2014.

ORDER

Since the grievance of the Complainant for replacement of damaged poles are performed by the Respondents the case is disposed off accordingly.

If aggrieved by this order, the complainant may represent to the Vidyut Ombudsman, 1st Floor, 33/11KV Sub-Station, Hyderabad Boat Club Lane, Lumbini Park, Hyderabad-500063, within 30 days from the date of receipt of this order.
