- 2. He submits that replacement of damaged cable which is erected in past 1968.
- 3. In replacement of Iron poles and short poles with 9.1 mtrs PSCC poles.
- 4. Erection of new cable for newly formed colony.

Notices were served upon the respondents duly enclosing a copy of complaint.

The respondent-III i.e. the Divisional Electrical Engineer /Operation /Chirala in written submission dt: 26.11.2014, received in this office on dt:27.11.2014 stated that:

- He submits that an estimate is prepared by Additional Assistant Engineer/Operation/Parchur for replacement of short poles at various location's in Veerannapalem village and submitted vide .Lr.No.AAE/O/PCR/D.No.410/14,dated.31.10.2014.
- 2. The estimate is sanctioned vide sanction no.SDR/IMP/133/2014-15.
- 3. The Assistant Engineer, Operation, Parchur is instructed to complete the work within one month.

Further The respondent-II i.e. the Assistant Divisional Engineer /Operation /Parchoor in written submission dt: 31.03.2015, received in this office on dt:01.04.2015 stated that:

He submits that replacement of short poles and middle poles and AB
cable at Veerannapalem against CG.No:177/14-15 was completed on
13.11.2014.

Findings of the Forum:

 Sri Makkena Sekhar Babu , the Sarpanch of Veerannapalem Gram Panchayat has made a complaint before the Forum during the Vidyuth Adalath conducted at Chirala on 16.10.2014, requesting to replace the damaged cable and provide new lines and intermediate poles.

- 2. The Respondents have completed the works on 13.11.2014.
- 3. During the Teleconference with Sarpanch to his mobile no 9949197035 on 26.04.2015 at about 12.45 pm, it is confirmed by the Sarpanch that the works as requested by the complainant are performed in full and the Sarpanch has also expressed his happiness for the same.

ORDER

Since the grievance of the Complainant has been redressed by the Respondents by providing additional lines and intermediate poles and replacing the damaged cable, the case is disposed off accordingly.

If aggrieved by this order, the complainant may represent to the Vidyut Ombudsman, 1st Floor, 33/11KV Sub-Station, Hyderabad Boat Club Lane, Lumbini Park, Hyderabad-500063, within 30 days from the date of receipt of this order.
