Sri A.Veera Vasantha Rao S/o A.Brahmaiah is a resident of D.No:185-1 Kondamuduaupalem village Kondamudusupalem Post Office ,Prakasam - Dist herein called the complainant, In his complaint dt:22-09-2014 filed in the Forum on dt: 22-09-201 4 under clause 5 (7) of APERC regulation 1/2004 read with section 42 (5) of I.E.Act 2003 has stated that:

1. He is a resident of D.No: 185-1 Kondamuduaupalem village Kondamudusupalem Post Office ,Kandukuru Mandal , Prakasam – Dist.

2. He had 10 Rooms building in Kandukuru city on the way to Government Hospital.
3. In front of his building there is a Transformer he wants to shift the same from that place.
4. He met with Officials of Electricity Office and paid an amount of Rs 76.565/- through DD on 19.09.2014 DD No.750597.
5. But the Transformer is not shifted from that place since five months
6. He lodged a complaint in the CGRF for justice.

Notices were served upon the respondents duly enclosing a copy of complaint.

The respondent-I to III i.e. the Assistant Engineer ,Assistant Divisional Engineer , Divisional Engineer /Kandukur in their combined written submission dt:02-03-2015, received in this office on dt:09-03-2015 stated that:

1. They submit that after Sanction of Estimate & Receiving of payment for shifting of DTR work was started for execution.
2. While execution of work Sri M.Srinivasa Rao who has raised objection about site dispute.
3. The Complainant Sri A.Veera Vasantha Rao has registered a complaint at Prajavani which is conducted by District Collector about the same work .
4. Sri M.Srinivasa Rao who raised objections while executing the work has also registered a complaint about to stop the work till the site dispute is cleared.
5. Because of the site dispute we are unable to do the work.The same was intimated to the complainant Sri .A.Veera Vasantha Rao to get resolve the dispute to complete the work.

Findings of the Forum:

CG.No:167/2014-15/Ongole Circle

As could be seen from the submissions of the Respondents, it is crystal clear that there is a site dispute in the Court of Law between the complainant and one by name Sir M.Sreenivasulu Rao regarding the possession and legal rights of the site in question where the transformer is to be shifted.

In view of the above, the Forum passed the following order.

ORDER

1. The Respondents are directed to complete the shifting of the transformer only after the dispute is cleared.
2. The complainant is advised to settle his differences with other parties on the site in question and show the Respondents about his rights on the site and get his transformer shifted without involving the Respondents into his personal problems.

Accordingly the case is allowed and disposed off.

If aggrieved by this order, the complainant may represent to the **Vidyut Ombudsman, 1st Floor, 33/11KV Sub-Station, Hyderabad Boat Club Lane, Lumbini Park, Hyderabad-500063**, within 30 days from the date of receipt of this order.
