Sri B.Murali Mohan resident of Kesavayanagunta ,Tirupati, Chittoor-Dist. herein called the complainant, In his complaint dt:22-12-2014 received & filed in the Forum on dt:16-02-2015 under clause 5 (7) of APERC regulation 1/2004 read with section 42 (5) of I.E.Act 2003 he has stated that

1. He is practising Advocate and consumer & tenant at Dr.No:19-14-60 2nd cross,Kesavayanagunta,Tirupati ,Chittoor-Distsince three months with ScNo:5522100097963 .
2. He said that it is common for display of Name Board in front of his house and the house purely domestic purpose.
3. He has received Provisional Assesement Order received from ADE/O/Tpt for unauthorized use of electricity.
4. Requested the Forum for Justice.

Notices were served upon the respondents duly enclosing a copy of complaint by CGRF.

Findings of the Forum:

1. The AAE/DPE I/Tpt has inspected the premises of the Complainant on 01.11.2014 at 13.50hrs.
2. The ADE/CCO/Tpt has booked the case under section 126(4) of Electricity Act 2003 for malpracticing the supply from the past three months.
3. The ADE/CCO/Tpt has issued a Provisional Assessment Order on 19.11.2014 duly assessing an amount of Rs 8522/- and asked the Complainant to pay 50% of the assessment amount of Rs 4261 + Supervisory Charges Rs 100/-.

In view of the above, the Forum passed the following order.

ORDER

Since The ADE/CCO/Tpt has booked malpractice case in terms of Section 126(4) of Electricity Act 2003, the Complaint will not fall under the purview of this Forum. Hence the Complainant is advised to approach the DE/Assessment/Tpt for redressal of grievance if any.

Accordingly the case is allowed and disposed off
