SriK.Anil Kumar ,Councillor,26th Ward ,Jaggaihpeta Municipality,Jaggaihpeta – Post Office ,Jaggaihpeta ,Krishna -Dist,herein called the complainant, In his complaint dt:16.10.2014 filed in the Forum on dt: 16.10.2014 under clause 5 (7) of APERC regulation 1/2004 read with section 42 (5) of I.E.Act 2003 has stated that:

1. He is a resident of 26th Ward ,Jaggaihpeta ,Krishna – Dist.
2. He lodged a complaint to provide a new breaker at Balsupadu sub – Station and removal of poles in middle road.

C.G.No:171/2014-15/Vijayawada Circle

Notices were served upon the respondents duly enclosing a copy of complaint.

The respondent-I i.e. the Assistant Divisional Engineer /Operation /Jaggiahpet in his written submission dt:nil, received in this office on dt:29.05.2015 stated that:

1. The Consumer Sri K.Anil Kumar, Councillor has complained that new breaker have to provided to Balsupadu Sub – Station remove poles in middle road.
2. The new separate breaker provided to Balsupadu sub Station on dt 12.11.2014 and poles removed.

Findings of the Forum:

1. Sri K.Anil Kumar , the 26th ward councillor of Jaggiahpet in his petition filed before the Forum has requested to arrange new breaker to Balsupadu substation and also requested to remove the middle road poles.
2. The Respondent No.1 in his submission dated nil received on 29.05.2015 has stated that he has provided a new separate breaker to Balsupadu on 12.11.2014 and also removed the poles in middle of the Road.
3. The complainant in his letter dated nil addressed to the CGRF received along with the submission of Respondent No 1 on 29.05.2015 has expressed his gratitude for the work done by the Respondents.

ORDER

Since the grievance of the Complainant to provide separate Breaker and to remove mid road poles have been completed by the Respondents to the satisfaction of the Complainant, the case is disposed off accordingly.

If aggrieved by this order, the complainant may represent to the **Vidyut Ombudsman, Andhra Pradesh ,Flat No:401 ,4th Floor, Ashoka Chambers, Opposite to MLA Quarters ,Adarsh Nagar,Hyderabad-500063**, within 30 days from the date of receipt of this order.
