Further The respondent-1 i.e, the Assistant Engineer/Operation/ Devamakonda in his written submission dt:31.01.2016, which is received in this office on dt:08.03.2016 stated that:

The factual report in connection with the problem overload the DTR cum low voltage problem the same problem expressed by the aforesaid consumer, in the letter dated 31.10.2015, the under signed have been created the estimate for proposing additional Distribution Transformer to the said consumers location, vide the estimate No:T-2015-08-03-34-01-051 to this effect the work order released and the work is now completed duly erected the Additional Distribution Transformer with the capacity of 25 KVA at the said location of Kutaikonda (V) of Devankonda (M) to avoid the low voltage problem of the said consumers.

- B. The Respondent 1 and 2 in their Joint letter dt 28.05.2016 received in the Forum on 13.06.16 has submitted an estimate No:T-2015-08-03-34-01-051 was sanctioned for erection of additional Distribution Transformer at Kutaikonda (V) to solve the low voltage and work is completed on 04.05.16 in all aspects. Sri U.Venkateswarulu complainant has expressed his satisfaction over phone for redressal of his grievance

In as much as the grievance of the complainant has been resolved by the Respondents to his satisfaction the case is disposed off.
