1. Sri D.Sakre Naik W/o Smt .Parvathi Bai has filed a complaint in CGRF on 07.01.2016 regarding shifting of LT line passing in the premises.
2. 1 no. intermediate pole erected in between the locations of HSC No.152458 and Smt Parvathi Bai location.
3. After erection of intermediate pole the LT line observed outside of the premises of the complainant . The same was intimated to the complainant over phone.
4. The photographs of the erection of the IP pole is here with enclosed.
5. This is submitted for favour of information necessary action please.

Findings of the Forum

1. The complainant in his application dt:7.01.2016 stated that L.T.line was laid unauthorizedly beside his house under construction .He had requested to shift the same.
2. The Assistant Divisional Engineer/D-II/Kurnool in his letter dated 15.03.2016 stated that 1 no. intermediate pole erected in between the locations of HSC No.152458 and Smt Parvathi Bai location.
3. After erection of intermediate pole the LT line observed outside of the premises of the complainant . The same was intimated to the complainant over phone.
4. The photographs of the erection of the IP pole is here with enclosed.
