ORDER

- 1. During the Vidyut Adalat conducted at Duggiralla, Guntur-dist on 12.05.2016 Smt Y.Jayalaksmi,
 - ZPTC, Chiluvuru presented a complaint seeking redressal of following grievances:-
 - 1. To fill up vacant field staff of Duggiralla mandal
 - a. Penumoli
 - b. Kanthamraju koduru
 - c. Thummapudi (SK.Nazeer, ALM is available)
 - d. Perkalapudi
 - e. Pedapalem
 - f. Chinapalem
 - g. Veeralapalem

- 2. To construct a new 33 KV SS at Morampudi village for which site is also provided
- 3. To erect additional power transformer at 33/11 KV Pedapalem SS.
- 4. To arrange alternate supply to 33/11 KV Pedapalem SS.
- 5. To arrange to shift SS-4 chivuluru agriculture DTR along roadside.
- 2. The Respondent No. 2 in his written submission has explained as follows:-
 - Filling up vacant posts, the subject has been brought to the notice of higher authorities.
 However he has submitted that day to day maintenance works and other emergency works are being attended by the distribution staff of nearby villages regularly.
 - Although site for construction new 33/11 kV SS shown by local villagers the site is not yet
 registered in favour of APSPDCL. After registration of the site and based on the feasibility
 report the subject matter will be dealt.
 - One no. additional 3.15 MVA power transformer was erected at 33/11 KV Pedapalem SS vide WBS element No:T-2016-02-04-11-01-032.
 - 4. For arranging alternate supply to 33/11 KV Pedapalem SS an estimate was already prepared and submitted to higher authorities vide WBS no: T-2016-02-04-11-01-033. Soon after receipt of sanction the work will be taken up.
 - The SS-4 100 KVA Chilvuru agl DTR was removed under HVDS scheme duly converting all LT networks into 11 KV line duly erecting one No.16 KVA and one no.25 KVA hence the problem is resolved.
- The complainant in her letter dated 25.05.2017 addressed to the Chairperson was conveyed her gratitude in resolving the grievances with the help of the Respondents.
- 4. Since the grievances raised by the complainant have been resolved by the Respondents to the extent of their portion and complainant herself expressed satisfaction the complaint is disposed of in favour of the complainant.
