## ORDER

- 1. Smt.J. Nagamunemma W/o. J.Venkata Subbaiah of Venkateshwarapuram, Madhavaram, Siddavatam (M) presented a complaint through post and the same was registered as C.G.No.210/2016-17. The complainant in her complaint has stated that though she has not requisitioned for extension of supply to her house when she was away from the village, the electricity department people have released service No.1204 in the name of A. Lakshmi Devi . She has requested to arrange to dismantle the domestic service unauthorizedly extended to her house in others name.
- 2. The Respondents 1,2 and 3 in their written submissions have explained that Smt. A. Lakshmi Devi resident of Madhavaram -1 Siddavatam (M) has applied for a new electrical service to her house bearing D. No. 3/76-1. While applying for the new service she has furnished a copy of the Panchayat Board house tax receipt for the year 2015-16

along with no objection certificate issued by the Panchayat Secretary Grampanchayat and copy of the Aadhar Card. As per the existing practice and rules in vogue, a new service connection was released in the name of Smt. A. Lakshmi Devi on 17.07.2016 with HSC No. 2345355001204. In the mean while the present complainant, i.e. Smt. J. Nagamunemma filed a complaint under MEEKOSAM on 17.10.2016. A reply was submitted to the District Collector through SE/O/Kadapa on 05.11.2016. The Complainant has filed the complaint duly furnishing house tax receipt for the year 2012-13, whereas Smt. A. Lakshmi Devi has submitted the tax receipt for the year 2015-16 which is the latest one and confirmed that Smt. A. Lakshmi Devi is the present owner of the house. The Respondents have further submitted that Smt. A. Lakshmi Devi after knowing that Smt. Nagamunemma has filed a complaint to the District Collector to dismantle her service connection furnished a representation on 25.10.2016, the request not to disconnect her service without her knowledge. The said Smt. A. Lakshmi Devi had also enclosed a copy of the agreement in support of her claim that she has purchased the house from the complainant on 04.11.2013. She has also produced a confirmation Secretary, Gramapanchayat, Madhavaram. Finally the certificate issued by the Respondents have made it clear that the complainant does not have any right on the house property and hence requested to reject the complaint.

3. On perusal of the averments made by the Respondents together with the documents, it is observed that the Respondents have rightly released the service in favour of Smt. A. Lakshmi Devi based on the house tax receipts issued by the Panchayat for the year 2015-16 and the no objection certificate furnished by Smt. A. Lakshmi Devi from the Secretary, Gramapanchayat. The complainant is claiming the title of the house which does not fall under the purview of this Forum. If such is the grievance the complainant is advised to proceed against Smt. A. lakshmi Devi by filing a civil case, if she so desires.
