ORDER

- Sri K. Koteswara Rao of New Machine Centre, Gurujala, Guntur Dist has presented a
 complaint before this Forum during the Vidyut Adalat conducted at Gurujala on
 11.10.2017. He has elucidated that for redressal of his grievance for shifting of electrical
 lines in his Agriculture fields for the ASC.No.1836 near Dandiwagu in Gurujala Town.
- 2. The Respondents No. 1 & 2 in their combined written submission has elucidated that they have contacted the complainant and explained him that he has to pay the shifting charges and has to register his Application at MEE-Seva duly furnishing his willingness to pay the cost of the estimate for shifting the over head HT lines. But the complainant had informed that he is not willing to pay the shifting charges. Due to non registration of application by the complainant in MEE-SEVA, the creation of DC estimate is not possible. Soon after payment made by either consumer or local bodies the work will be carried out duly by following the departmental procedure in vogue.
- 3. In accordance with the provisions contained in Rule No.5.3.4 of General terms and conditions of supply as approved by the Hon'ble Commission the consumer shall pay the shifting charges included in the estimate in advance before taking up shifting operations.

4. In view of the above rule position, the Complainant is advised to register his application at the MEE -SEVA centre along with his consent letter to pay the cost of the estimate. The Respondents are directed to take up the shifting operations after receipt of deposits from the Complainant. Accordingly the complaint is disposed off in favour of the Respondents.
