The Respondents 2, 3 and DE/O/Rajampet submitted their joint written submissions wherein they have explained that the service under question was inspected by Respondent No..2 on 20.09.2017 and suspected the meter is creeping. Hence advised the complainant to pay the meter testing charges, accordingly the complainant has paid the said testing fees on 06.10.2017. The meter of the said service connection was replaced with healthy one on the same date and the removed meter was sent for testing on 02.11.2017. During the testing the
