- The complainant filed a petition before this Forum for shifting of lines passing over her house.
- 2. Respondent No. 2 submitted his written submission before the Forum wherein he stated that an estimate was prepared as per the request of the complainant and the same was sanctioned for an amount of Rs. 48,553/-. The demand notice was served to the complainant but she did not turned up for payment of shifting charges. Respondent No. 2 also submitted that the complainant requested to reduce the charges since she was unable to pay the estimated amount. It was not possible to reduce the estimate charges and hence the work will be started after receival of payment from the complainant.
- 3. When the complainant was contacted over phone by this Forum to the complainant contact number registered with the Forum, her son in law Sri. Venkatesh replied that the respondents intimated them to pay the shifting charges and also stated that now they are
