ORDER

1. Complainant filed a petition before this Forum regarding shifting of 11 KV Line passing over SC Colony near bus stand in Pathapadu village.
2. Respondent.No.3 in his written submission to the Forum elucidated that the 11 KV line was erected long back and at the time of erection of lines there was no housing colony, consequently the houses came up under these lines. As per the GTCS, the consumer has to pay the shifting charges.
3. The Respondent No.3 further submitted an estimate of shifting of 11 KV feeder from existing location to the new location at SC Colony in Pathapadu village was prepared and got sanctioned for an amount of Rs.4,65,991/-, but the payment is not yet received either from the complainant or Gram Panchayat authorities. Soon after the receipt of payment, the work will be carried out in due course of time.
4. In view of the explanation given by Respondents complainant is advised to pay requisite estimation amount for resolving their grievance. Accordingly the case is disposed off.


