#### **ORDER**

- 1. The case of the complainant is that both the 11 KV line feeding the agriculture supply and the LT line feeding domestic services are lying and erected on the same poles because of which the agriculture motor pump sets getting burnt and requested for shifting of 11 KV line.
- The Respondent No.1 in his written submission submitted to the Forum stated that the complaint was verified and found that proper clearance is being maintained between agriculture supply and LT supply lines.
- 3. A personal hearing was conducted and both parties attend.
- 4. Both parties reiterated the same facts of written submission which were earlier submitted to the Forum.
- 5. The Respondents being the technical persons stated that they had inspected the location of the complainant and found that the domestic line is existing with 2 core cable and there is proper clearance between the 11 KV line and LT line. On other hand the complainant didn't submit any proof in support of his version that the agriculture pump sets were being burnt only due to the existing HT/LT line.

6. In the result, the complaint is dismissed.
