ORDER

1. Complainant presented a complaint in the Forum regarding release of new Agriculture service connection.
2. The Respondents No. 1 , 2, & 3 had submitted joint reply to the Forum wherein they have stated that during HVDS works the complainant registered the LT application for agriculture purpose and estimate was prepared vide WBS no: A-0283-04-06-31-02-0136. The estimate was sanctioned on 01.05.2017 but the payment was not made by the consumer.
3. Since the Respondents have already processed the complainant's application and estimate was also sanctioned by the Respondents, the Forum finds no fault on the Respondents.

During the teleconversation with complainant's son to the mobile number 9966162181, he has confirmed that he has paid LT application registration fees for release of agricultural services connection and not paid development charges and security deposit . He has also confirmed that since he is not in a position to pay the amount as per the demand notice he has withdrawn his application and will register a fresh application.
5. The complainant is advised to register an application afresh for obtaining Agriculture connection. Accordingly the complaint is disposed off.
