**ORDER**

1. Complainant Sri B.Madhusudan Reddy filed a petition in this Forum regarding the following grievances.
  - a. Dismantling of idle pole located in his field.
  - b. Providing of solar pump set.
2. The Respondents No. 1, 2 & 3 have submitted a joint written statement stating that the complainant didn't agree to remove the pole as there are banana trees around the pole. So, the Respondents intimated the complainant that they will carry out dismantling of pole work after harvesting the crop for which the complainant has also agreed.
3. The Respondents further submitted that the complainant had not registered his application for solar power and he was intimated to register an application for solar power .
4. Subsequently Respondent No.1 sent a mail dated : 31.07.2018 that the pole was removed. The Complainant is also advised to register an application for solar power.
5. Accordingly the case is disposed off in favour of complainant.


