The Respondent No.1 further submitted that during erection of the electrical line in the site under question the complainant did not raise any objection and as on today he had not constructed any construction in the said site. as per the provisions of Electricity Act, 2003, the APSPDCL has every right to erect electrical poles and transformers at any place in the interest of general public but the owner of the said site or land cannot object as per the Act.
