He had received an assessment notice for regularization of additional load of 107.96 HP On 19.09.2009. Whereas the complainant paid an amount of Rs. 28,500 for regularization of 19 HP on 30.05.2013. Since the complainant did not fully paid the assessment amount his service was disconnected. He requested the Forum for reconnection to the unit and to allow them to pay normal electricity charges bill excluding the assessment amount and finally requested the Forum to do justice.
- 2. Respondent No.1 submitted his written statement stating that Respondent No.2 had inspected the complainant premises on 06.07.2018 and reported that the load is only 48 HP basing on which the Respondent No: 3 had issued final assessment order to nill. The developmental charges of Rs.1,18,000/- has been withdrawn wide RJ No. 3-9/2018.
