ORDER

1. Complainant filed a petition before the Forum for shifting of lines passing through his agricultural field.
2. Respondents No. 1 and 2 in their details submission to the Forum elucidated that 33 KV line passing through the complainant land was laid long back and it is feeding supply to the Marella substation and others. The lines were laid to provide better supply to the consumers and in the interest of public. The complainant had been informed by the Respondents for filing of an application in the Mee-seva Centre for shifting of the lines with the consent letter to pay the shifting charges as for the departmental procedures but the complainant did not come forward to register the application.

In view of the above the complainant is hereby advised to register an application in the Licensee is notified Centre duly enclosing his statement expressing his willingness to pay the necessary shifting charges and also to look after the right of way problems in accordance with Para's 5. 3. 4 and 5. 2. 4 of General Terms and Conditions of Supply accepted by the Hon'ble Andhra Pradesh Electricity Regulatory Commission.
