ORDER

1. Complainant Sri V.V. Chandrasekhar Reddy , 16/62-A, S.N.Puram of Gudivada filed a petition before the Forum regarding shifting of the transformer to avoid insecurity feeling in the public , and transformer short circuit problems .
2. Respondents No. 1, 2, 3 in their joint written submission stated that the Respondents No. 1 and 2 inspected the transformer under question and noticed that there is no problem to the public. Respondents also submitted that if the complainant wants to shift the distribution transformer compulsory to new location, he has to file an application as per the departmental procedure for shifting distribution transformer and he has to pay the necessary sanction estimate charges and he also show the convenient place where there is no objection for erection of the distribution transformer.
3. The complainant is informed that there is no problem to the public with the transformer under question. If he wants to shift the transformer he is hereby advised to submit an application in Licensee's notified centre duly enclosing his statement expressing his willingness to pay the necessary shifting charges and to look after right of way problems in accordance with Para's 5.3.4 and 5.2.4 of General Terms Conditions of Supply approved by Hon'bel APERC.


4. Accordingly the case is disposed off in favour of Respondents.
