**ORDER**

1. The case of the complainant is that he is having service No.1733208000152 under Category -3 with 5 HP load for his prawn culture in Harrispet. Subsequently he applied for additional load of 44 KW and conversion of service to 24/7 Hrs. Deputy Executive Engineer issued a proceeding estimating the cost at Rs.1,67,020/- on 07.06.2019. Even though he is the owner of the tank security deposit was estimated 3 times intentionally on the ground that he has not paid the amount. DEE /O/ Cherukupalli booked a case for additional load on 20.02.2019 and imposed a fine of Rs. 61,800/- and he paid that amount. But the amount paid by him towards fine Rs.61,800/- and an amount of Rs.44,000/- towards security deposit was not deducted from the estimated amount. When he approached DEE/Operation/
