**ORDER**

1. The case of the Complainant is that on 20.10.2018 at about 13.10 Hrs the inspection was carried out to his premises and a case was booked under malpractice and the assessment period was taken from 20.10.2017. But the complainant had not actually opened his clinic on 20.10.2018. But he was carrying out arrangements for his clinic. He had taken a portion of premises on lease for the period of 2 years from 15.10.2018 to 14.10.2020 only. He had not received any notice from the respondents and not acknowledged the same. The electrical appliances that were present in his premises were only two ceiling fans one table fan and 3 bulbs. The DE/Assessments/TPT issued orders to pay Rs.5,550/-. He had made representations to SE/Assessments/TPT on 28.01.2019 and on 09.09.2019. Finally he requested the forum to do natural justice
2. Respondent No.1 submitted written submission to the forum wherein he submitted that the final assessment order was issued for Rs.515/-. The complainant had paid the notice amount.
