ORDER

1. The case of the complainants is that they are the owners of the commercial building bearing D. No 20/25-A , abutting the main Road, Near RTC bus Stand, Guntakal . The buildings are consisting of two (2) portions having 3 electricity connections bearing No's HSC No.8396, 20132 and 023878 in the name of K. Ramanjineyulu , G. Sathish Kumar and G. Ramu respectively in the electricity records. Previously there were 3 sheds in the site and they were dismantled and those connections were changed to USC No's: 7221301008396, 7221301020132 and 7221301023878 respectively. But those service connections were changed in the name of one Jayam Gopinath S/o. Late Jayam Achaiah of Bellary without any notice and inspite of their request the names were not changed and requested to replace their names in the registers for the above service connections.
2. Respondent No.1 filed written submission stating that service No.7221301008396 is in the name of K. Ramanjineyulu and service was in dismantle status. So also service No.7221301020132 is in the name of G. Sathish Kumar and that service also is in

dismantle status. Service No.7221301023878 is in the name of G. Ramu and that service also at present is in dismantle status.

3. Respondent No. 4 also filed written submission on similar lines. Bill details of service No.7221301023878 shows that it is in the name of G. Ramu and the service was disconnected on 28.09.2018. So also the service connection No. 7221301020132 is in the name of G. Sathish Kumar and the service was disconnected on 31.01.2018. The service Connection No. 7221301008396 is in the name of K. Ramanjineyulu and that service was also in dismantle status as on 14.08.2018.
4. We are not able to understand as to why the complainant filed this complaint when there was no transfer of the said 3 services and on the other hand they were already dismantled. There is no cause of action for this complaint.
5. There are not merits in the complaint. Hence the complaint is dismissed.

If aggrieved by this order, the Complainant may represent to the **Vidyut Ombudsman, Andhra Pradesh**, 3rd Floor, Sri Manjunatha Technical Services, Plot No:38, Adjacent to Kesineni Admin Office, Sri Ramachandra Nagar, Mahanadu Road, Vijayawada-520008 within 30 days from the date of receipt of this order.
