**ORDER**

1. G. Ammani resident of P.K. Layout, Tirupati presented a complaint before this Forum wherein she has submitted that she has purchased a small house bearing Sy.No.233/2 of Tiruchanur Grama Panchayat and got it registered in sub registrar office, Renigunta vide Document No.5067/2010. She has also obtained approval from TUDA for the above site vide D.DS. L.R.S. 4347/2010 Dt :17.10.2011. She has constructed compound wall around her plot. When she has tried to construct a small house with sheets, R. Balaji resident of Plot No.100 and Damodar Reddy Ex surpanch Kotramangalam along with several others demolished the compound wall. They are claiming the site belongs to them. Further she has submitted that she has noticed electrical supply was extended to the premises duly erecting new meters. Hence requested to arrange to dismantle the service connections un-authorisedly obtained by R. Balaji and Damodar Reddy
2. Respondent No.1 in his written submission has explained that domestic service was released bearing No. 5522100162127 on the document submitted by M. Sabarinath Reddy. On receipt

of the complaint from the complainant a notice was served on M. Sabarinath Reddy to furnish survey report of revenue authorities in support of his claim over Sy.No.233/2. But the said Sabarinath Reddy failed to furnish Survey report and hence the service connection was disconnected on 22.06.2019 thus resolved the grievance of the complainant.

3. During the tele conversation with the family member of the complainant by the Secretary Forum to the registered mobile No. in the complaint at 12.00 P.M. on 24.07.2019 the family member of the complainant expressed satisfaction in disconnecting the service connection.
4. Since the grievance of the complainant has been resolved by the respondents the complaint is disposed off in favour of the complainant.


