ORDER

1. The present complaint is filed that service No. 9232206000275 is released under domestic category. In the month of January her neighbour requested to use it for the motor on the ground that neighbour's generator is having problem. Since then neighbour is using it. Prior to that the meter reading was 1150 units. She received a notice that the supply is used for commercial purpose for which she agreed. But she was not able to understand how the inspecting officer assessed 1447 units when the meter reading is below 1400 units as on 10.01.2020. Only 200 units was used for commercial. Hence requested to correct the same.

Since the averments of the complaint shows that a case under Sec.126 of the Electricity Act, 2003 for indulging in un- authorized use of Electricity, notice was issued for hearing maintainability of this case before the forum.

- 2. Consumer was informed about hearing the case through video conferencing by phone by the staff of the forum on 10.08.2020 and on 25.08.2020 .Complainant when contacted over the phone on 25.08.2020 at 11.40 A.M., it was represented that he will not attend the video conferencing. Complainant failed to attend the video conferencing.
- 3. Point for determination is whether the complaint is maintainable before this forum when a case is registered against the complainant under Sec. 126 of the Electricity Act, 2003?

The averments of the complaint clearly shows that a case for indulging unauthorized use of electricity was registered against the complainant.

Sub Clause (b) of Clause No. 10.2 of Reg. 03/2016 provides that the forum may reject the complaint at any stage under the following circumstances which is as follows:

Clause No. 10.2:" The forum may reject the complaint at any stage under the following circumstances:

a).....

b) In cases which fall under Sections 126,127, 135 to 139 and 152 of the Act.

c).....

d)........"

Provided that no complaint shall be rejected unless the complainant has been given an opportunity of being heard".

Since the case is registered against the complainant under Sec. 126 of the Electricity Act, 2003 and as the complainant is questioning about the quantum of assessment imposed by investigating officer and as there is an opportunity to the complainant to prefer an appeal to appellate authority under Sec. 127 of the Act. Hence the forum is of the opinion that the complaint is not maintainable before the forum and liable to be rejected.

4. In the result the complaint is rejected.
