## **ORDER**

- 1. The case of the complainant is that a service connection was given to an un-authorized occupant of his house while suit is pending filed against one Miss. Pakala Bujjamma D/o. Pakala Chalamaiah vide Case No. 233 of 2014 on the file of Senior Civil Judge, Kavali. Complainant requested to furnish the certified copies of documents filed by her for taking service connection. He has also applied for documents under RTI Act, 2005. But documents were not furnished. Complainant is seeking for removal of service connection and certified copies of the documents said to have been submitted by P. Bujjamma D/o. Chalamaiah for obtaining service connection.
- 2. Since complainant is seeking certified copies of the documents under RTI Act and stated that service connection was given during the pendency of the suit, the Forum's of the opinion that complaint is not maintainable before this Forum. Hence posted for hearing the complaint in respect of maintainability of the complaint before the forum.

- 5. The forum may reject the complaint when a civil suit is pending for the same subject matter as per Clause 10.2 (a) of Reg. 03/2016 which is as follows:

"The forum may reject the complaint at any stage under the following circumstances:

a) In cases where proceedings in respect of the same matter and between the same complainant and the Licensee are pending before any court, arbitrator or any other authority, or a decree or award or a final order has already been passed by any such court, tribunal, arbitrator or authority.

Provided that no complaint shall be rejected unless the complainant has been given an opportunity of being heard".

In view of the above specific provisions of Regulation. No. 03/2016 as stated above the complaint is not maintainable before this Forum.

to provide information sought by the complainant, RTI Act itself provides remedy to
