ORDER

- 1. K. Lakshmi Devi proprietor of M/s. Amulya Animal Feed Industry filed complaint stating that the department levied huge amount of CC bill of Rs. 2,71,788/- for the months of July and August'2020. Complainant further stated that even the machines have not started until receipt of the CC bill. Hence requested to withdraw the huge amount of CC bill levied by the department.
- 2. / Respondent No.4 submitted in his written submission stating that the HT Sc No. TPT-2577 of M/s. Amulya Animal Feed Industries Mekalavaripalle Madanapalli (M) Chittoor Dt has availed supply with CMD of 108 KVA

under 11 KV voltage potential under HT Cat-III (A) on 04.07.2020. As per the statement of respondents No.1 and 2, the KWH and KVAH abnormal high consumption recorded and variation KWH and KVAH was happened due to DTR internal problems. Hence revision of bill recommended by the respondents No.1 and 2 for the month of July'2020 in respect of said HT SC No. TPT-2577. Respondent No.4 has withdrawn an amount of Rs.1,42,785/- by raising RJ vide RJ No. 26-11/2020 as per recommendation of Respondents No. 1 and 2 the bill was revised as per the specific condition of 4.3.1 Cat-III(A) Industry (General)-HT in Chapter-X of Tariff Order- 2020-21.

- 3. When secretary of the forum contacted complainant over phone on 07.12.2020 at 1.15 P.M. Complainant expressed her satisfaction in resolving their grievance.
- 4. In as much as the grievance of the complainant is resolved by the respondents, the complaint is disposed off in favour of the complainant.
