- The case of the complainant is that respondents while carrying out HVDS work left his service No. 5633101000108 without providing distribution transformer.
- Respondents filed written submission stating that estimate was prepared, after sanction and allotment of DTR the same will be erected to the AGL service of the consumer.
- 3. Complainant when contacted by the staff of the forum over phone on 08.06.2020 at 1.25.P.M he stated that he is not having supply and no nearby Distribution Transformer is available to feed supply to his AGL land.
- 4. Respondents themselves admitted that the service connection of the consumer was left over while HVDS work was carried out and they have prepared estimate, after approval of estimate and allotment of DTR they will provide it to the consumer. Consumer also represented that there is no nearby DTR to provide supply to his AGL service connection.
