ORDER

- Mr.P.Antony & Others, Guttakinda Indlu, Pakala (M), Chittoor Dist. have presented a complaint before this Forum during the Vidyut Adalat conducted at Pakala on 21.09.2022. In their complaint they elucidated regarding shifting of electrical lines passing through their houses. Hence requested the Forum to clear their problem and requested to remove the electrical lines passing through their houses.
- 2. The Respondent No.1 in his written submission has elucidated that complainant and others have to pay the estimate cost for shifting of line which is passing through their houses and further stated that if the consumers come forward to pay the shifting charges, they will immediately shift the line which is passing through their houses, after getting sanction of estimate from higher authorities.
- 3. Point for determination is whether it is possible to shift the electrical lines passing through the complainant &others houses or not?

Clause 5.4.1.4 read with 5.3.4 of GTCS is as follows:

Cl. 5.4.1.4: The service line once laid shall not be transferred or shifted from one place to another except with permission of the Company. If a consumer

desires to have the position of the existing service line altered the Company will take action for shifting of service in possible cases subject to the provisions in 5.3.4.

5.3.4 Charges for shifting of service:

The estimate for shifting the existing service will cover the following items as chargeable to the consumer:

- i. Dismantling charges at the old site;
- ii. Transport charges from the old site to the new site.
- iii. Re-erection charges at the new site;
- iv. Depreciation on the old materials if any not reused at the site;
- v. Over head charges;
- iv. Cost of new materials if required; and Cost of irretrievable materials. The consumer shall pay the above charges included in the estimate in advance before taking up shifting operations.
- 3. In accordance with the provisions contained in Clause. 5.4.1.4 read with Clause.No.5.3.4 of General terms and conditions of supply as approved by the Hon'ble Commission, the consumer is liable to pay the shifting charges. If he is willing to bear the line shifting charges, after approval of estimate only.
- 4. In view of the above, the consumer is advised to show the feasibility for shifting of the line as per field conditions. Further the Respondents are advised to act accordingly after following the departmental rules, regulations and formalities as per field conditions which is enforced to resolve the problem as shown by the complainant.
- 5. Accordingly the case is disposed off.
