ORDER

- 1. The Sub Divisional Engineer, BSNL, Dharmavaram filed a complaint complained that their HT service HTSCNo.ATP-273 was dismantled on 14.9.2022 and their service turned to LT service bearing Service number SC No.7621202061828 on the same day. They requested the department to adjust the outstanding SD charges amount available against dismantled HT SC No.ATP-273 to their LT service connection SC No. 7621202061828.But their greivance was not resolved. Hence requested the forum to resolve their greivance.
- 2. The case was registered as C.G.No.01/2023-24/Ananthapur Circle and sent to respondents for written submissions.
- 3. Respondent No.3 has submitted written submissions on 27.5.2023 stating that, in compliance to the notice issued by the Hon'ble Forum for the Redressal of Consumer Grievances, APSPDCL, Tirupati in CG No.01/2023-24/ATP the following is herewith filed towards the written submission which is as follows:

- 1) The HT SC No. ATP273 standing in the name of Sub-divisional Officer, Telecom, BSNL, Dharmavaram got disconnected and bill stopped as per the consumer's request and HT Agreement stood terminated w.e.f. 14.09.2022 as per Clause 5.9.4.3. of the GTCS.
- 2) In the course of termination, an adjustment amounting to Rs. 2,43,015-59 has been made towards balance CC Charges (Rs. 37981.88) and True-up Charges (Rs. 2,05,033-71) + FPPCA Charges (Rs. 59,888-50) from the available Security Deposit of Rs. 4,22,720/-. Thus, the residual SD against the HT service is descent to Rs. 1,19,815-91 owing to the above said adjustment.
- 3) The above adjustments have been made vide RJ No. 18/3-23 (in Mar'23) and RJ No. 8/5-23 (in May'23), respectively.
- 4) Based on the consumer's representation received from the Dy. Executive Engineer/Operation/Dharmavaram, the residual SD amounting to Rs. 1,19,815-91 has also been transferred to ERO/Dharmavaram through Inter-unit Adjustment communicated vide SAP Doc. No. 100059445/dt. 08.05.2023 for crediting/adjustment of the same against the CC Charges of the requested LT service viz., 7621202061828.

As the request of the complainant, consumer has been met at this end, positively, and intimated to the consumer vide letter the Hon'ble Forum is humbly requested to dispose the complaint, accordingly, please.

4. When the staff of the forum contacted over phone @ 11.00A.M. on 27.5.2023 with SDE/BSNL/Dharmavaram to the Registered mobile number 9490121700, he replied that their grievance is resolved, hence expressed his satisfaction and requested to close the case.(Satisfaction letter sent through mail).

5. In as much as the grievance of the complainant is resolved by the respondents, the complaint C.G.No.01/2023-2024/Ananthapur Circle is disposed off.
