### **ORDER**

- 01. The complainant filed the complaint stating that he applied for electrical service connection in mee-seva but service connection was not released by the respondents.
- 02. The said complaint was registered as C.G.No.79/2023-24 and notices were issued to the respondents calling for their response. The respondents

submitted their response stating that the complainant registered application for new service connection on 02.11.2023 with contracted load of 2 KW but he did not furnish the necessary documents and as such the service connection was not released. But, however, subsequent to this complaint. on 16.11.2023 the complainant submitted the necessary documents and on the same day service connection was released with S.C.No. 7112201194712 and the issue was closed.

- 03. Heard the respondents through video conferencing. The complainant remained absent.
- 04. Subsequent to filing of the complaint, the respondents released the service connection to the complainant and the grievance of the complainant is resolved.
- 05. Since the grievance of the complainant was resolved, this Forum opines that this complaint is to be closed since the purpose is served. No order as to costs.
- O6. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Hon'ble Vidyut Ombudsman, 3<sup>rd</sup> Floor. Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the

date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
