- O4. The respondents filed copy of the letter issued by the complainant reporting that the service connection was released to him and his grievance was redressed. When this Forum contacted the complainant through phone he admitted the contents of the letter issued by him and stated that service connection was released to him and reported no objection to close the complaint as his grievance is redressed. Hence, the complaint is closed. There is no order as to costs.
- O5. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3<sup>rd</sup> Floor, Plot.No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
