This complaint came up for final hearing before this Forum through video conferencing on 05.03.2024 in the presence of the respondents and the complainant remained absent and having considered the material placed by both the parties, this Forum passed the following:

ORDER

- 01.** The complainant filed the complaint during the Vidyut awareness camp conducted at Dharmavaram on 16.02.2024 stating that he applied for agricultural service connection but it was not released.
- 02.** The said complaint was registered as C.G.No.142/2023-24 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that subsequent to the




complaint, they erected the DTR and released the agriculture service connection of the complainant on 26.02.2024 and thereby redressed the grievance of the complainant.

03. Complainant absent. Heard the respondents through video conferencing.
04. Subsequent to filing of the complaint, the grievance of the complainant is resolved by the respondents. The complainant did not attend the enquiry through video conferencing, but when we contacted him through phone, he reported that the respondents released agriculture service connection and his grievance is redressed and further requested to close the complaint. Accordingly, the complaint is closed. No order as to costs.
05. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
