This complaint came up for final hearing before this Forum through video conferencing on 05.03.2024 in the presence of the respondents and the complainant remained absent and having considered the material placed by both the parties, this Forum passed the following:

ORDER

01. The complainant filed the complaint stating that he applied for agricultural service connection but so far the same is not released.
02. The said complaint was registered as C.G.No.144/2023-24 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that the complainant applied for agricultural service connection on 02.02.2024, estimation



was sanctioned on 08.02.2024, the complainant paid the amount against the demand on 13.02.2024 but the DTR allotted to the complainant as per seniority and then the work will be executed.

03. Heard both the parties through video conferencing.
04. According to the respondents, they are releasing the agricultural service connections as per the seniority in the priority list maintained by the department. Hence, the complainant has to wait for some more time until his turn comes. The respondents are directed to release the service connection to the complainant as per his seniority in the priority list. Accordingly, the complaint is closed. No order as to costs.
05. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
