
This complaint came up for final hearing before this Forum through video conferencing on 03.12.2024 in the presence of the complainant and respondents and having considered the material placed by both the parties, this Forum passed the following

ORDER

- 01.** The complainant filed the complaint stating that he is residing in Balajikota Street, Porumamilla and about three years back the respondents laid electric line over their private site in front of their


residential house inspite of their objection and the said line is very nearer to their house walls from the roof exposing threat to their lives and the respondents did not hear their objection and hence this complaint.

02. The said complaint was registered as C.G.No.71/2023-24 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that subsequent to the complaint, they have shifted the electric line from the existing location to another location and resolved the issue.
03. Heard complainant and respondents through video conferencing. The respondents submit that subsequent to the complaint they have shifted the electric line from the present location to another location. The complainant during the enquiry admitted that the respondents shifted the existing electric line to another place and their problem is solved. Since the grievance of the complainant is redressed, the complaint is closed. There is no order as to costs.
04. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of




