## **ORDER**

- 1. The complainant submitted a representation during Vidhyuth Adalath conducted at Srikalahasthi on 16.06.2023 stating that he is having ASC No.5432200006096. Due to hanging of lines between the poles he is getting supply interruptions frequently to the said agricultural service and also removed jumpers. For the past six months he is unable to make cultivation. Hence requested the forum to tighten the lines between the poles and also requested to restore his agricultural service connection.
- The case was registered as C.G.No.07/2023-24/Tirupati Circle and sent to Respondents for written submissions.
- 3. The Dy.EE/O/Srikalahasti and AE/O/Srikalahasti submitted joint written submission stating that the consumer Sri. SK. Mahaboob Basha complained for re-connection of said Agriculture service. On 18.06.2023 the premises was inspected and found that jumpers are badly damaged in LT spur line and
