This complaint came up for final hearing before this Forum through video conferencing on 07.05.2024 in the presence of the respondents and the complainants remained absent and having considered the complaint and submissions of both the parties, this Forum passed the following:

## <u>ORDER</u>

**01.** The complainants filed the complaint stating that they applied for agricultural service connection for which the neighbours objected

and on that ground the respondents refused to release service connection.

**02.** The said complaint was registered as C.G.No.161/2023-24 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that to release the service connection to the complainants the service line is to be laid by erecting poles in the neighbouring land and the neighbouring land owner did not agree for erection of poles and they issued notice to the complainants asking them to clear the objection for execution of work but there was no response from the complainants.

03. Complainants absent. Heard the respondents through video conferencing.

- **04.** During the course of enquiry the complainants remained absent and there was no representation for them. It seems that the complainants have no interest to prosecute their complaint. Hence, the complaint is dismissed for default. There is no order as to costs.
- 05. The complainants are informed that if they are aggrieved by the order of the Forum, they may approach the Vidyut Ombudsman, 3<sup>rd</sup> Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the
