This complaint came up for final hearing before this Forum through video conferencing on 20.02.2024 in the presence of the respondents and the complainant remained absent and having considered the material placed by both the parties, this Forum passed the following:

ORDER

o1. The complainant filed the complaint stating that there are DTCP layout sites in Jambuvaripalli (V) in which the respective owners constructed houses, that in the layout certain public places are gifted to the Gramapanchayat, Jambuvaripalli vide registered Gift Deed Dt: 22.02.2018, that in the said public place roads were laid and street

lights were also provided under service connection SC Nos' 5611300006367 and 5611300005488 under Category.No.II but they requested to change the commercial Category No.II to Category No. IV since the said service connections are under the maintenance of the Gramapanchayat/Government, but the respondents are not responding.

- Were issued to the respondents calling for their response. The respondents submitted their response stating that subsequent to the complaint they changed the category from II to IV on furnishing of necessary documents by the complainant. Prior to the complaint, as the complainant did not furnish the necessary documents, they could not change the category.
- 03. Complainant absent. Heard the respondents through video conferencing.
 Heard the complainant through cell phone.
- O4. The complainant when we called him through phone confirmed that subsequent to the complaint he submitted the copy of the registered Gift Deed and other required documents to the respondents on which the respondents changed the category from II to IV on 27.01.2024 and reported that their grievance was redressed. Hence, the complaint is closed. No order as to costs.

05. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot.No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and website prescribed format is available in the vidyutombudsman.ap.gov.in.
