ORDER


01. The complainant filed the complaint during the Vidyut Adalat conducted on 09.12.2024 at Anantapur stating that he applied for an agricultural service connection by paying necessary deposit amounts in November'2023, but the respondents did not release the service connection till this date.


02. The said complaint was registered as C.G.No.245/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint, they released service connection.
03. Heard the respondents through video conferencing. Complainant remained absent. The respondents erected distribution transformer and released service connection and also submitted satisfaction letter issued by the complainant to that effect. Since the grievance of the complainant is redressed, the complaint is closed. There is no order as to costs. The secretary of the Forum is instructed to forward a copy of this order to the complainant herein through whatsapp and Post.
04. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot.
