


ORDER


- 01.** The complainant filed the complaint during the Vidyut Adalat conducted on 09.12.2024 at Anantapur stating that they applied for two agricultural service connections in the name of his wife on 04.01.2024 but till this date connections are not released.

02. The said complaint was registered as C.G.No.246/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint they released the service connections on 04.01.2025.
03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that on receiving the complaint they released the service connections. The complainant issued letter of satisfaction confirming the release of the service connections in the name of his wife. Since the grievance of the complainant is redressed, the complaint is closed. There is no order as to costs.
