
ORDER


- 01.** The complainant filed the complaint during the Vidyut Adalat conducted on 09.12.2024 at Anantapur stating that they applied for agriculture service connection and paid necessary deposits in August'2023 but so far the department did not release the service connection.

02. The said complaint was registered as C.G.No.247/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint, they released the service connection.
03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that on receiving the complaint, they released the service connection. The complainant issued letter of satisfaction confirming the release of the service connection. Since the grievance of the complainant is redressed, the complaint is closed.
