This complaint came up for final hearing before this Forum through video conferencing on 05.02.2025 in the presence of the respondents, complainant remained absent and having considered the material placed by both the parties, this Forum passed the following

ORDER

01. The complainant filed the complaint stating that she is having service connection SC.No.7112301072085 and the respondents issued CC bill for the month of January 2025 for huge amount and hence the CC bill is to be revised.

- **02.** The said complaint was registered as C.G.No.253/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that the CC bill for the month of January'2025 was issued as per the Tariff Order for Retail Sale of Electricity for F.Y. 2024-25 and FPPCA Charges are arrived as per the instructions of the Hon'ble APERC and there is no abnormality in the CC bill.
- 03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that the CC bill for the month of January'2025 was issued as per the Tariff Order for Retail Sale of Electricity for F.Y. 2024-25 and FPPCA Charges are arrived as per the instructions of the Hon'ble APERC and there is no abnormality in the CC bill. We perused the bill in question and it is as under:

charges, electricity duty, FPPCA Charges installments for the years 2022-23 and 2024 and true up charges, the bill was generated for Rs.323/- and the respondents claimed the above charges as per the instructions of the Hon'ble APERC and Tariff Order 2024-25 and hence there is no abnormality in the CC bill issued by the respondents. Hence, this complaint is devoid of merits and is dismissed. There is no order as to costs.

O4. The complainant is informed that if she is aggrieved by the order of the Forum, she may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
