The complainant during the enquiry submit that after the complaint, he changed his mind and requested the respondents for erection of dedicated transformer instead of the return of the deposit amount and accordingly they erected the same and requested to close the complaint. The complainant also issued letter of satisfaction about redressal of his grievance. Considering the circumstances, the complaint is closed as the grievance of the complainant is redressed. There is no order as to costs.
