

ORDER

01. The complainant filed the complaint stating that 11 KV line is passing over their house causing obstructions for further construction and it is to be shifted.



02. The said complaint was registered as C.G.No.250/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint they shifted the line to the satisfaction of the complainant.
03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that on receiving the complaint, they shifted the line. The complainant issued letter of satisfaction confirming shifting of the line. Since the grievance of the complainant is redressed, the complaint is closed. There is no order as to costs. The secretary of the Forum is instructed to forward a copy of this order to the complainant herein through whatsapp and Post.
